

Nursery Pupil Premium Grant (PPG) 2017/18

Nurseries receive an additional payment called Pupil Premium Grant (PPG), for each three and four year old pupil whose parents are in receipt of certain benefits, those who are in care of the local authority or (from April 2014) are adopted and those whose parents are serving in the armed forces. In 2017 -18 this grant was based on £300 per pupil – based on 15 hours of nursery. Tamworth Nursery have been allocated a PPG of £427.15 generated from 6 eligible pupils in the Autumn Term (6/10) (25% of pupils).

For the majority of pupils at Tamworth Nursery there are significant barriers to learning and achievement and we are using our PPG to try and reduce the negative impact of some of these barriers, increase access to differentiated and appropriate curricula and raise the level of attainment and progression for all.

Nursery Pupil Premium Grant (PPG) 2016/17

Nurseries receive an additional payment called Pupil Premium Grant (PPG), for each three and four year old pupil whose parents are in receipt of certain benefits, those who are in care of the local authority or (from April 2014) are adopted and those whose parents are serving in the armed forces. In 2016 -17 Tamworth Nursery were allocated a PPG of £1273.34 generated from Autumn term - 5 children (45% of all pupils), Spring 6 children (55% of all pupils) and Summer 10 children (1 of whom was CLA) (62.5% of all pupils) eligible pupils.

For the majority of pupils at Tamworth Nursery there are significant barriers to learning and achievement and we are using our PPG to try and reduce the negative impact of some of these barriers, increase access to differentiated and appropriate curricula and raise the level of attainment and progression for all.

Nursery Pupil Premium Grant (PPG) 2015/16

Nurseries receive an additional payment called Pupil Premium Grant (PPG), for each three and four year old pupil whose parents are in receipt of certain benefits, those who are in care of the local authority or (from April 2014) are adopted and those whose parents are serving in the armed forces. In 2015 -16 Tamworth Nursery were allocated a PPG of £409.43 generated from 5 eligible pupils (25% of pupils).

For the majority of pupils at Tamworth Nursery there are significant barriers to learning and achievement and we are using our PPG to try and reduce the negative impact of some of these barriers, increase access to differentiated and appropriate curricula and raise the level of attainment and progression for all.
